

## Summer Shine a Light 2017 Sweepstakes

### OFFICIAL RULES

**No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.**

**Promotion Period:** Summer Shine a Light 2017 ("Sweepstakes") begins July 1, 2017 and ends August 31, 2017. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

**How to Enter:** Individuals will receive an automatic entry into the Sweepstakes when they log into Access 360 between July 1, 2017 and August 31, 2017, and have added at least one account to their account overview. One entry per household.

The 3X5 card **MUST BE ENCLOSED IN A NEW STANDARD, BUSINESS SIZE ENVELOPE SIZED AT 4-1/8" x 9-1/2"**. **A return address MUST BE on the envelope.** Geezeo is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Mechanically reproduced entries will not be accepted. Alternate entries are limited to one per household and you MAY NOT send in multiple entries for multiple financial institutions. **Eligibility:** Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be a resident of the 50 United States (D.C.), Guam and Puerto Rico and be 18 years or older.

**Employees, Board members and consultants of CODE Credit Union and its subsidiaries, and their family members within the same household are not eligible to win.**

**Selection of Winners:** Winners will be chosen by random selection the week of September 9th, 2017, from all eligible entries received during the Promotion Period from all participating financial institutions. There will be a total of five (5) prizes: \$250.00 grand prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize.

For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

The arrangement of the prize distribution will be handled between the Prize Winner and Geezeo/ CODE Credit Union. Geezeo/ CODE Credit Union does not guarantee any specific rates or stock availability. No prize substitution is allowed.

The odds of winning are approximately 1 in 30,000; however, actual odds of winning will depend upon the number of entries received from all participating financial institutions. Final determination of winners will be made by a staff member of Geezeo, whose decision is final.

Arbitrator decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT. The place of arbitration shall be in the County in which you reside.
